## JUSTICE VS THE LAW

Then not that long ago in Colorado, a group robs a bank, witnessed by many. The thieves are caught the same day. In the decision of death to the villain, the execution was often within 24 hours, witnessed by the community.

In Aurora, Colorado, James Eagan Holmes attended the midnight showing of the movie, THE DARK KIGHT. Twenty minutes into the film, Holmes left his front row seat, departed the theatre's back door, returned about 12:30 am wearing a mask and protective clothing, carrying gas canisters and guns. He discharged the canisters of smoke or gas, began shooting indiscriminatingly with 12 gauge shotgun, changed to a Semi-automatic with a a 100 round magazine, which malfunctioned after a few rounds, then continued firing a Glock 40 cal hand gun.

In about the time it required to read this, twelve died and seventy were casualties.

Holmes was apprehended at 12:45 am, outside the theater, next to his car. On interrogation he stated he had booby-trapped his residence which Officers disarmed. There is no indication Holmes claimed to be innocent of these acts.

The theatre of the Old West Justice has been replaced.

Today we are introduced to the Theater of the Absurd with crimes like that of Jim Holmes. In three years here has been no trial, yet legal opinions of every possible outcome have been quoted in the media.

This might seem elementary.

A jury should be asked, Did Holmes commit these murders, attempted murders?

If found guilty, that jury should be discharged.
